

TERMS AND CONDITIONS

Waterloo Station Hotel – “Dragon’s Fortune” Promotion

1. The Promoter is LHG3 PTY LTD (“Promoter”) of 800 Toorak Road, Hawthorn East, Victoria 3123 trading as Waterloo Station Hotel (“Hotel”).
2. Information on how to enter and Prizes to be won form part of these terms and conditions. Acceptance of a Prize is conditional upon accepting these conditions.
3. The name of the promotion is “**Dragon’s Fortune**” (“Promotion”).
4. The Promotion will be held at the Hotel commencing at **9am on Thursday, 4th October 2018** and concluding at **4.45pm on Saturday, 1st December 2018** (“Promotional Period”). The major draws will be conducted in accordance with clause 11 below. This is a Gaming Room Only promotion.
5. The Promoter encourages and practices the responsible service of alcohol and gambling at all times. In addition, the Promoter takes its obligations and responsibilities under Liquor, Gaming and other relevant Regulations and Acts very seriously.
6. The Promotion Total Prize pool is \$10,000 which is split into the following Prize Values:

11. The winner's will be determined via a random draw from the entry barrel by the Gaming Manager. Draw will be located in the gaming room only.
 - a. There will be 9 x envelopes containing the 'Major Prizes'.
 - b. As each winner is drawn and confirmed, the winner will get to select one of the nine envelopes; their prize will be determined by the dollar value contained inside the envelope, draws will continue at the allotted times until all nine prizes have been won.
